# **Privacy Policy**

### Access data / server logfiles

When you access our website, information of a general nature is automatically recorded. This information (server logfiles) contains details about the visitor's operating system, file name of the retrieved web page, date and time of retrieval, amount of data transferred, message about successful retrieval, browser type plus version, referrer URL (the previously visited page), IP address and the domain name of your Internet service provider. This is only information that does not allow conclusions about your person. These details are technically necessary to correctly deliver content of web pages requested by you and are absolutely necessary when using the internet.

#### Cookies

Cookies are small text files that are transferred from a webserver to your hard drive. Cookies can not be used to launch programs or to transfer viruses to a computer. Based on the information contained in cookies, we can facilitate navigation and enable the correct display of our website.

In no case will the data collected by us be passed on to third parties or a connection with personal data will be established without your consent. After the end of the browser session, most of the cookies used will be deleted from your hard drive ("session cookies"). The so-called "persistent cookies" remain on your computer, allowing it to recognize you on your next visit. You can deactivate the use of cookies at any time via the settings of your browser. Please use the help features of your browser to find out how to change these settings. Please note that some features of our website may not work if you have disabled the use of cookies.

#### Personal data

When using the ticket order for the Wave-Gotik-Treffen, we collect personal data only in the context of the ordering process and save these in a database as well as in generated PDF files that serve as an invoice for shipping. The following data is collected here: Invoice number, timestamp of the order, session id, surname, first name, address, city and country, e-mail address, purchased tickets as well as the timestamp when your payment is received by us.

#### Deletion or blocking of data

We adhere to the principles of data avoidance and data economy. We therefore only store your personal data for as long as this is necessary for the purposes set out above or as provided for by the various storage periods provided for by the legislator. After discontinuation the respective purpose or expiration of these periods, the corresponding data is deleted routinely and according to the legal requirements.

## Your rights to information, correction, suspension, cancellation and opposition

You have the right to receive information about your personal data stored by us at any time. Likewise, you have the right to rectification, blocking or, apart from the prescribed data storage for the transaction, deletion of your personal data.
